## **Fair Housing Protected Classes by State**

In addition to the seven protected classes under federal FHA (race, color, religion, sex, handicap/disability, familial status, and national origin), state fair housing laws extend protections to other groups. Here's a rundown of the current additional protected classes in each state, as of July 1, 2025:

**Wisconsin:** Age, ancestry, sexual orientation, gender identity, marital status, domestic abuse, sexual assault or stalking victim status, source of income, pregnancy
